The total amount is 180 hours. (6.0 ECTS credits)

The form of participation is remote

The internship is organized as part of the work of the Publishing Group "Scientific Perspectives" and in cooperation with the public scientific organization "Ukrainian Assembly of Doctors of Sciences in Public Administration" and the public organization "Association of Scientists of Ukraine"

The internship is conducted with the aim of improving qualifications and exchanging experience with foreign colleagues on modern aspects of modernization of public administration, law, economics, medicine, psychology and other fields of science based on innovative technologies

Internship program:

Module 1

Academic mobility in education, 60 hours:

- o systematization and analysis of forms of implementation of the mobility of professors and teaching staff and instruments of its state support;
- o integral classification of forms of international student mobility;
- o organizational and legal mechanisms for expanding the "export" of educational services.

Module 2

Innovative directions of the development of the branches of science: the experience of the Czech Republic, 70 hours:

- o external conditions and framework of the long-term forecast of scientific and technical development;
- o possible consequences of implementing global challenges and trends for science in the Czech Republic;
- o breakthrough technologies and promising innovations capable of making a significant contribution to the solution of the most important problems of fundamental research in the fields of science.

Module 3

Education and scientific research in the conditions of modern economic development.

Innovations and teaching methods, 50 hours:

- o models of state policy development in the field of higher education in developed countries of the world;
- o improvement of the system of statistical indicators of innovative development of science and technology policy;
- o reforming the legislation of the Czech Republic in order to stimulate and integrate scientific, scientific and technical activities and education: an innovative aspect.

- consulting on obtaining Certificates of knowledge of the English language at levels B2, C1, A1, A2, B1, as well as on international recognition of diplomas on education in Great Britain, advanced training for civil servants and participation in international scientific and educational projects;
- provision of consulting services regarding the publication of articles in publications of category B, as well as Scopus, WoS, etc. journals.

The cost of an international internship: 180 euros (calculated on the date of payment). To participate in the internship, it is necessary to send the application and photocopies of the first pages of the foreign passport to the e-mail address naukovi.perspectuvu@ukr.net. Payment is made only after sending confirmation of receipt of materials (details for payment are sent in the reply letter).

ACCORDING TO THE RESULTS OF THE INTERNSHIP, THE STUDENTS WILL BE ISSUED CERTIFICATES AND SENT TEACHING AND METHODOLOGICAL AND INFORMATIONAL MATERIALS FOR INDEPENDENT PROCESSING



The certificate and its content comply with the provisions of the Resolution of the Cabinet of Ministers of Ukraine dated April 13, 2011 No. 411 "Issues of student training and internship (scientific internship) of graduate students, adjuncts and doctoral students, scientific and scientific-pedagogical workers in leading higher educational institutions and scientific institutions abroad", Resolution of the Cabinet of Ministers of Ukraine of August 12, 2015 No. 579 "On the approval of the Regulation on the procedure for the implementation of the right to academic mobility", internal administrative documents of the Higher Education Institutions of Ukraine on the organization of the educational process for post-graduate students (those seeking higher education with the degree of Doctor of Philosophy) regarding postgraduate or doctoral studies.

Also, we draw your attention to the fact that academic title holders can confirm their international experience remotely. The relevant clarification was provided by the Ministry of Education and Science of Ukraine.
